Mike Tonks is authorised by that licence to provide financial advice.

Nature & Scope of Advice

Mike Tonks of Mike Tonks Limited trading as RMA Financial provides advice to clients about their Life, Trauma, Disability and Health insurance and ACC structuring. Mike Tonks Limited provides financial advice in relation to these financial advice products.

Mike Tonks Limited only provides financial advice about products from certain providers:

- For Life, Trauma & Disability insurance, I work with five companies
 - AIA, Asteron Life, Cigna, Fidelity Life and Partners Life.
- For Health insurance, I work with three providers
 - AIA, NIB and Partners Life.

In providing you with financial advice, we will consider both your existing and unmet personal risk needs. We will not provide advice on existing whole of life or endowment products, so you will need to consult a specialist if you would like advice on those products.

Other Services

Where Mike Tonks cannot provide advice on products such as Mortgages, Investment and Fire & General Insurance, he has Business Partners he can refer you to. Mike Tonks has referral agreements in place that may see him being compensated should you choose to work with these Partners. This will be explained to you before you are referred and will also be documented in the Advice Report.



Fees & Conflict of Interest

Mike Tonks Limited may charge a fee for the financial advice provided to a client where no compensation for work done is received from a provider. Any fees that will apply to an engagement will be explained and agreed with the client beforehand. RMA Financial and our Financial Advisers receive commissions from the providers on whose products we give financial advice (the insurance providers). If you decide to take out insurance after advice, the provider will pay a commission to Mike Tonks Limited, your financial adviser. The amount of commission is based on the amount of the premium. From time to time, product providers may also reward us for the overall business we provide to them. For example, they may give us fruit baskets, hampers, or other gifts. To ensure that we prioritise the client's interests above our own, we follow an advice process that ensures our recommendations are made on the basis of the client's goals and circumstances. All the RMA Financial Advisers undergo annual training about how to manage conflicts of interest. We maintain a register of any conflicts of interest and we also have annual compliance auditing processes in place.

Complaints

We will consider your complaint and let you know how we intend to resolve it. We may need to contact you to get further information about your complaint. We aim to resolve complaints within 10 working days of receiving them. If we can't, we will contact you within that time to let you know we need more time to consider your complaint. We will contact you by phone or email to let you know whether we can resolve your complaint and how we propose to do so. Mike Tonks Limited keeps a complaint register and is part of the Insurance & Financial Services Ombudsman (IFSO) which provides a free independent dispute resolution service.
