The professional fees we charge will vary according to the nature of the services we provide.

Financial Planning \$ 2,250 + GST

Fee This may be adjusted for complex planning based on an hourly rate of

\$195 + GST. Any fees charged will be payable within 14 days following the issue

of an invoice.

Investment Nil (if the initial investment is \$50,000 and over)

Administration Fee \$195 + GST per hour (if the initial investment is less than \$50,000)

The fee is payable within 14 days following the issue of an invoice.

Life and Health Insurance Unless agreed otherwise in our Scope of Service, we do not require payment of a fee directly from you as a result of the activities we undertake on your behalf as a

commission is generally paid by the insurer.

If there is a fee for payment in relation to Life and Health Insurance, this will be specifically detailed in your Personal Insurance Plan or in other documentation

and will be based on an hourly rate of \$195 + GST.

### **HOW WE WORK WITH YOU**

Managh Financial Ltd has duties under the Financial Markets Conduct Act 2013 relating to the way that we give advice, including:

- Meeting standards of competence, knowledge and skill set by the Code of Professional Conduct for Financial Advice Services (these are designed to make sure that we have the expertise needed to provide you with advice)

- Meeting standards of ethical behaviour, conduct and client care set by the Code of Professional Conduct for Financial Advice Services (these are designed to make sure we treat you as we should, and give you suitable advice).

To ensure that we prioritise your interests above our own, we follow an advice process that ensures our recommendations are made on the basis of your individual goals and circumstances. We maintain a conflicts of interest register, which is reviewed annually by our governance team. We undertake a compliance audit, and a review of our compliance programme annually by a reputable compliance adviser.

For life insurance and health insurance, we receive commissions from insurance companies on whose policies we give advice. The amount of the commission is based on the amount of the premium.

For investment, we receive an adviser fee from investment companies on whose funds we give advice. The amount of the adviser fee will vary between companies and the amount of your investment.

## IF SOMETHING GOES WRONG

If you are not satisfied with our financial advice service you can make a complaint by emailing amanda@rmafinancial.co.nz or feedback@rmafinancial.co.nz; or by calling 0272529490. You can also write to us at PO Box 215, Silverdale 0944.

When we receive a complaint, we will consider it following our internal complaints process:

- We will consider your complaint and let you know how we intend to resolve it. We may need to contact you to get further information about your complaint.
- We aim to resolve complaints within 10 working days of receiving them. If we can't, we will contact you within that time to let you know we need more time to consider your complaint.
- We will contact you by phone or email to let you know whether we can resolve your complaint and how we propose to do so. If we can't resolve your complaint, or you aren't satisfied with the way we propose to do so, you can contact the Financial Disputes Resolution Service (FDRS). FDRS provides a free, independent dispute resolution service that may help investigate or resolve your complaint, if we haven't been able to resolve your complaint to your satisfaction.
